Early Childhood Education Regulatory Review

For information

The Early Childhood Education Sector Regulatory Review continues to analyse and test initial findings and recommendations with the Ministry of Education, Education Review Office, Ministry of Health and Ministry for Primary Industries regulatory subject matter experts. The purpose of testing is to:

- Understand the level of agreement on our findings and recommendations.
- Document where there is disagreement on our findings and recommendations.
- Confirm where additional information is required.
- Describe the implications of our recommendations, including risks and trade-offs.
- Discuss the cost and time required for implementation.

To date, we have held eight testing workshops covering regulatory monitoring, regulatory capability and performance, licencing criteria (multiple workshops), regulatory tools, curriculum,

qualifications and ratios, regulatory strategy, approach, culture and leadership. Our initial findings on licencing criteria will be provided to you on 18 October.

This week we have provided you with a report summarising the themes from all engagement and a briefing that outlines our lines of inquiry and an early view of the economics workstream.

Agricultural and Horticultural Products Regulatory Review

For information

This week the Agricultural and Horticultural Review team tested issues that came through the submissions process and underlying causes with agencies. This is a key step in verifying our analysis of the issues raised by stakeholders.

The first substantive meeting of the Sector Reference Group was held on Tuesday 8 October. Discussion focused on the raw outputs from the issues and causes workshops and the initial options under consideration by the Review.

Feedback on issues raised was generally positive, noting that there was a broad range of perspectives to incorporate. They made suggestions of potential alternative ways of structuring some issues, and these will be considered as the issues and causes work further develops.

The Sector Reference Group provided constructive feedback on the options provided. s9(2)(f)(iv)

RRT2024- 034	Anti-competition in the Building Products Marketplace (Council Pre-Approved Products Lists)	The submitter has raised concern that some councils have a public list of pre-approved building products. The submitter considers this to be anti-competitive as smaller suppliers with less well-known products are not included in these lists. The submitter considers this results in greater market success by larger companies favoured by Councils in these pre-approved product lists.	MfR will prepare a letter to the submitter indicating it intends to investigate the issue further.
RRT2024- 035	Healthy Homes Standards	The submitter has raised a concern that requirements under the Healthy Homes Standards (HHS) have added burden and cost for little (health) benefits for tenants.
