Early Childhood Advisory Committee (ECAC) meeting 5 June

Following your formal announcement of the regulatory sector review of early childhood education (the review) at the Khandallah Little School, including a media stand-up, you are scheduled to attend an in-person meeting of the Early Childhood Advisory Committee (ECAC). ECAC is a group of sector representatives that provide advice to the Ministry of Education and is working with the Ministry for Regulation on the review. The meeting will provide you an opportunity to discuss the

recently announced sector review and terms of reference, outline your early childhood education priorities, and engage in questions with the group.

The Ministry for Regulation's sector review team will spend an hour with ECAC group following your session. ECAC will be able to provide the sector review team with their experience, advice and expertise on areas for improvement in the regulatory system. As part of a broader engagement plan, the Ministry for Regulation will continue to engage with ECAC and other early childhood education advisory groups established by the Ministry of Education.

Updates

Organisation Design

Sector Review into Early Childhood Education

The Cabinet paper was considered by SOU on 29 May and will be considered by Cabinet on 4 June. We have been engaging with your office on arrangements for announcements on 5 June. We have also been liaising with the Ministry of Education and the Education Review Office on communication channels to help push the announcement out. You are scheduled to attend the Early Childhood Advisory Committee session on 5 June from 1pm, and Ministry for Regulation officials have an hour to discuss the sector review with that committee following your session.

Some providers have written to your office raising concerns about the approach to building regulation following the Loafers Lodge tragedy. There is a particular issue around door handle heights, which need to be below a certain height to ensure safe exit (required by the Building Code) but which also need to ensure that children cannot open them themselves and leave a centri (required by ECE licensing criteria). We will consider this issue as part of the review, and the team have already begun investigating it.

Similarly, we are also considering the laundry temperature issue raised by stakeholders as part of he review and have already begun investigating.

Future sector reviews

Following our discussion with you on 28 May, we have refined the proposals to review the path to market for products in agriculture. We have also engaged further with sector stakeholders (Animal and Plant Health New Zealand, and Agritech New Zealand), and liaised with the relevant agencies. Our advice is set out in briefing 2024-034 and recommends that you discuss options with Ministers Hoggard and Simmonds.
