Policy development - interagency workshops on options

For information

Over the last week we have run two in eragency workshops to test options for:

- the core components of he Regulatory Standards Bill; and
- streamlining and strengthening the regulatory policy process

The workshops gave agencies a chance to share with us any ideas they have which they would like considered and fl g what they might see as issues we need to address before providing policy advice. The engagement gives us an understanding of what issues might come up during ministerial consultation.

The workshops were well attended with attendees from the following agencies attending at least one of the workshops: DPMC, Treasury, Crown Law, MBIE, Ministry of Justice, Parliamentary Counsel Office, Department of Internal Affairs, Ministry for Primary Industries, Ministry for Social Development.

From the discussion on the Regulatory Impact Analysis (RIA) we are specifically reflecting on feedback shared by attendees on: (1) the importance of RIA requirements and (2) the quality assessment of the RIA and discussion documents, for maintaining a minimum standard of policy analysis across government. We also heard that Regulatory Impact Statements (RIS) could be

shorter and more accessible be most helpful decision makers. An attendee from the Policy Project, a unit in DPMC that aims to support and grow the capability of policy advisors across government, was present to hear the feedback.
