
Below is an update on progress against the PSC indicative milestones to 1 July.



Cabinet will have agreed a plan for the Ministry's priorities, work programme and operating model	Cabinet has previously agreed its intentions for the Ministry. We have advised you on the key functions the Ministry will need to have to deliver on those. Further functions are being refined as part of policy work on the Bill and RIA system.  The establishment CE has been engaging with you on the operating model, work programme and central agency role.
The substantive CE will have been appointed and be engaging with you on the full operating model and work programme for the Ministry, and plans for building the Ministry as a central agency	Appointment process for the substantive CE is underway (by PSC).  The establishment CE has been engaging with you on the operating model, work programme and central agency role.
The substantive CE will have a blueprint for the new organisation and will commence replacing secondees with longer term staffing, decisions on the location of the Ministry and substantive arrangement for its corporate services	The establishment CE has finalised the organisational structure and has commenced recruitment process for senior staff including Tier 2 roles.  Substantive arrangements for the Ministry's corporate services (including location) are well underway.

### **Agricultural Products Regulatory Review**

The draft Cabinet Paper and terms of reference were revised to respond to the feedback from Joint Ministers. On 2 July we started both agency consultation on the draft Cabinet Paper and sector consultation on the draft terms of reference, with responses due by midday on 9 July. We will provide an Aide Memoire to Joint Ministers on 9 July that summarises the feedback received, and any changes made, and provide updated copies for Ministerial and Coalition consultation, which is due to start on 10 July.
