Ministry for Regulation participation in MBIE/Business NZ roundtable events

As discussed with your office, officials from the Ministry for Regulation are scheduled to attend roundtable meetings with small and medium sized enterprises and manufacturers who have been invited to discuss their compliance burdens with government. The events will occur from 18 – 31 July in various locations. Event organisers, MBIE's Small Business Services and Business New Zealand, will facilitate the meetings and provide a general structure to the conversation. We understand representatives from Inland Revenue will also attend.

It is likely that the conversations will shed light on the nature of compliance issues facing small and medium sized businesses. We will provide you with a summary of the meetings once they have concluded. We understand MBIE and Business New Zealand will compile a report from the round table events for publication later this year.

Regulatory Sector Review into Early Childhood Education

For information

The Ministry's engagement hub went live on Friday, 5 July and as of noon Thursday, 11 July had attracted 261 responses. We consider this to be a high response rate. Responses can be received via questionnaire or by uploaded written submission. The questionnaires are being translated into te reo Māori. A breakdown of the submissions is below, including some information about the demographics of those who have submitted. We have received one written submission so far.

Responses at 12:00pm, 11 July 2024:

Parents and caregivers	112
People who work in ECE	126
Service providers	9

For parents and caregivers:

- The majority have children who attend centre-based services (92%)
- The majority have children who attend ECE more than 21 hours per week (75%)
- Most have children in the 3 years to 5 years age bracket (65%)
- Respondents are from a spread of locations across New Zealand

For people who work in ECE:

- The majority are qualified teachers (81%)
- The majority work in centre-based ECEs (51% private ECEs and 24% community-based)
- The majority have worked in ECEs for more than 11 years (70%)

For service providers

- We expect service providers' responses to increase substantially in coming weeks. Service
 providers are likely to be working across their leadership teams and Boards to fill in the
 questionnaire.
- Just over half are centre based ECEs, with the remaining being home-based and one university service.
- There is a mix of responses from services that operate one or a small number of services to two that operate more than 100 services.

Other interested people:

• A significant number of these responses are from people who used to work in ECE (40%) and academics and researchers (20%).
