#### Early Childhood Education Regulatory Review

As at 17 July we have received over 400 submissions with 380 coming through the engagement platform, as well as 43 written submissions. We are expecting more from providers and from bodies who are making submissions on behalf of members. The submissions through the engagement platform have come from:

- parents 157
- workers 192
- providers 15
- others 19

In the next two weeks the team will be visiting ECEs in the Auckland, Manawatu, Wellington and Canterbury region. This includes a meeting with Pasifika providers and workers in Auckland as well as the Early Childhood Council conference in Christchurch on 10 July.

#### Agricultural and Horticultural Products Regulatory Review

#### For information

Ministerial and coalition consultation on the Cabinet Paper for the review closed on 17 July. The paper was lodged on 18 July, for the Expenditure and Regulatory Review Committee meeting on 23 July and Cabinet on 29 July. On the 18<sup>th</sup> July we provided talking points for the Committee meeting. which you may want to share with Ministers Hoggard and Simmonds. We are also continuing to plan for the launch on 1 August and are engaging with your office on the arrangements.

The Ministry for Primary Industries (MPI), the Ministry for the Environment (MfE), and the Environmental Protection Authority (EPA) have made some of their staff available part-time to support the review team directly. This includes both technical experts and some general policy resource.

We have also engaged with Professor Alan Reilly, the former Chief Executive of the Food Safety Authority of Ireland. Professor Reilly was originally going to undertake a review of the Agricultural Compounds and Veterinary Medicines regulatory system alone for MPI, but this was paused in light of the regulatory review being announced.

The Senior Officials Advisory Group for the review had their first meeting on 17 July. The group will provide advice and support for the review team, including addressing any roadblocks, and will support alignment with related policy processes. The group is Chaired by Establishment CEO Ministry for Regulation and includes senior leaders from MfE, EPA, and MPI/New Zealand Food Safety. The group discussed how the review will intersect with initiatives already in progress, and the need and opportunity to align implementation of any resulting changes to the regulatory systems. The group noted that the review team will need to be very disciplined in managing the stages of the review, including in managing stakeholder engagements to meet the timeline for the review.

On 17 July the review team met with the Agricultural Compounds and Veterinary Medicines Advisory Council, which advises the Ministry for Primary Industry on the control of agricultural compounds and veterinary medicines. Members asked who would be responsible for managing any changes to legislation following the review, and whether the scope of the review would look beyond current issues to "future-proofing" the system to ensure it can provide suitable pathways for new innovative products.

This is a relatively recent change in policy, implemented earlier this year. s 9(2)(g)(i) However, at this stage industry participants and small councils are well connected to trials for ongoing expansion of recycling categories. Further work from us at this stage would duplicate work underway by MfE and the sector. We recommended that 9(2)(ba)(i) be prioritised for upcoming future trials to collect more materials, which was a satisfactory outcome for them. We will monitor progress, especially in relation to the rationale for regulation and quality of cost-benefit analysis on economic impacts on the sector in future policy changes.
