



Advertisements for our three Deputy Chief Executive vacancies closed on 9 August, with over 100 applications received across the three roles. Shortlisting will occur over the next 2 weeks with initial interviews expected to commence by the end of August. Offers are expected to be made to preferred candidates approximately mid-September.

Interviews are underway for the leadership roles within the Regulatory Reviews group, with many high calibre applicants being considered. ### Agricultural and Horticultural Products Regulatory Review

For information

On 9 August the review team provided a briefing to Joint Ministers that set out the economic analysis that would be undertaken as part of the review and a draft Economic Analysis Issues Paper to generate further targeted stakeholder input (MFR2024-090). We are seeking to discuss the workstream and the issues paper with you at the Agency meeting on 13 August.

On 6 and 7 August, the Environmental Protection Authority held introductory sessions on the Hazardous Substances and New Organisms regulatory system. These helped set some foundational understanding of the regulatory system for the review team, and provided an opportunity to ask a range of detailed questions on how it operates. These followed on from an equivalent session on the Agricultural Compounds and Veterinary Medicines regulatory system last month.

On 5 August a member of the review team attended a panel discussion on global dairy subsidies, organised by Dairy Companies Association of New Zealand (DCANZ). While the review is not concerned with subsidies, it provided an opportunity to understand some of the economic considerations that will be relevant for the Review. DCANZ is working with the Ministry for Primary Industries on an economic model to estimate the impacts of dairy subsidies.

The review team also met with a further part of MPI to understand the trade and market access implications of the use of agricultural and horticultural products. We will be engaging with them later in the review to understand the impacts our options may have for global trade partners and the regulators of importing countries.
