


Agricultural and Horticultural Products Regulatory Review

The Approach to economic analysis in the Agricultural and Horticultural Products Regulatory Review paper was published on the Ministry for Regulation website on 20 August and has been

promoted on LinkedIn and in engagements with stakeholders. You also put out a press release promoting the paper on 21 August.

This week the team met with 24 organisations including agriculture and horticulture producer groups and major manufacturers. Some key points raised by stakeholders included:



Next week the team will be meeting with major exporting businesses and groups bringing views from public health, environment, and research & development.

On 21 August, the final workstream lead joined the review team, meaning the full resourcing is now in place.

Early Childhood Education Regulatory Review

For information

Over the last four weeks the team have had many in-person engagements with ECE service providers, teachers and staff as 'regulated parties' across the country to get a first-hand understanding of the day-to-day work of teachers and other workers and see the requirements of the regulatory framework in action.

From 26 July, visits have been made to kindergartens, education and care services, home-based services, a playcentre, and a hospital-based service. These visits have been in Auckland, Horowhenua, Manawatū, Kāpiti, Central Plateau, Waikato, and Canterbury. We also attended the full ECE conference in Christchurch where we engaged with many providers and other stakeholders. The experience of these visits has been an important part of our analysis and evidence base. In addition, two days were spent shadowing an Education Review Office (ERO)review of an ECE centre in Albany and there have been a series of meetings with ERO staff and Ministry of Education staff.

During this period, the team have also been engaging with other regulatory organisations in a targeted manner to understand the specific role they have within the ECE regulatory system and

what opportunities exist for change. This has included WorkSafe, MBIE Building and Construction, FENZ, Teaching Council, Health NZ and MPI (for food safety).

You can expect to see a series of reports over the coming weeks as the review progresses into the next stages.



	RRT is considering this issue and will update you.
Individual	Section 22AB(1)(d) of the Land Transport Act 1998 authorises a road controlling authority (RCA) to make a bylaw fixing the maximum speed of vehicles on any road. Rule 2.3 of the Land Transport Rule: Setting of Speed Limits 2022 is more specific. It would seem that RCAs, in drawing the boundaries of the area of the designated speed limit area, appear not to consider the advantage of designating separately the 2 halves of a road.


