## **Executive Summary**

This report summarises the feedback Treasury received as part of agency consultation on the draft Regulatory Standards Bill Cabinet paper that we provided for your review on 5 February (T2024/171 refers).

It summarises feedback provided during agency consultation, and provides you with an updated version of the Cabinet paper, with Treasury's proposed changes to reflect departmental feedback.

It also notes that we have now commissioned the Crown Law Office (CLO) to provide formal advice on the Bill by 26 February.

Subject to your agreement and further comment, we recommend that this updated version of the paper be used as the basis for Ministerial consultation ahead of the paper being lodged on Thursday 22 February.

### **Recommended action**

We recommend that you:

- a **note** that the updated version of the draft Cabinet paper incorporates the majority of the feedback provided by consulted agencies
- b **note** that the table in the Annex provides a summary of all feedback provided and how Treasury has reflected this in the paper
- c **provide** any further feedback on the draft Cabinet paper so we can supply you with an updated version for Ministerial consultation beginning 20 February.

# **Treasury Report:** Agency consultation on the draft Regulatory Standards Bill Cabinet paper

# Purpose of report

- 1. This report:
  - updates you on feedback provided during agency consultation on the draft Regulatory Standards Bill Cabinet paper
  - provides you with an updated version of the Cabinet paper, with Treasury's proposed changes to reflect agency feedback.

### Consultation with agencies

- 2. The Cabinet paper was sent to targeted agencies, including those with Regulatory Management System responsibilities, on 9 February 2024, with feedback sought by 15 February 2024.
- 3. The agencies consulted with were the Department of the Prime Minister and Cabinet (DPMC), Ministry of Business, Innovation and Employment (MBIE), Parliamentary Counsel Office (PCO), Public Service Commission (PSC), Crown Law Office (CLO), Ministry of Justice (MoJ) and Te Arawhiti.
- 4. Some of the relevant contacts from these agencies also sit on the Legislative Design and Advisory Committee (LDAC) and provided feedback in that capacity.
- 5. The main focus of the feedback was on ensuring clarity that the proposed approach has potentially significant constitutional and resourcing implications, and that further work will need to be done to fully understand these, and to mitigate any risks and unintended impacts.
- 6. Other substantive feedback included clarifying the timeframe around next steps, and the provisions and scope of the Bill.
- 7. Agency feedback and how we have addressed it is summarised in **Annex One** to this report. An updated Cabinet paper with tracked changes is attached as **Annex Two**, and a clean copy of the updated draft is attached as **Annex Three**, for your review.

### Next steps

9. Once you have reviewed Treasury's proposed changes, and provided any further feedback on the Cabinet paper, we can provide you with a final draft for Ministerial consultation.

10.	We understand that you propose to circulate the draft Cabinet paper for Ministerial consultation beginning Tuesday 20 February. Your office would then lodge the paper on Thursday 22 February, to be discussed at EXP Committee on Tuesday 27 February and Cabinet on Monday 4 March.
